Supports	GemStone generally follows conventions for navigating the user interface from the keyboard. In cases where keyboard commands do not execute product functions, the accessibility features of the Windows and MacOS operating systems provide keyboard navigation for the user.
(b) Applications shall not disrupt or disable activated features of other products that are identified as accessibility features, where those features are developed and documented according to industry standards.
